We are a natural medicine family and have not participated in any allopathic medicine for over 7 years.

Our firstborn was vaccine injured and it took us many years of research and pain to learn the truths about big pharma and the vaccine industry and how it harmed him. Subject: COVID-19 vaccine mandates at xxxxx

Hello,

I am writing to you due to concerns that I have that xxxxx might decide to mandate the COVID-19 vaccines upon its workforce.

We have seen recently the Canadian Government stating that all federal employees and federally regulated industries (banks, airlines, etc.) need to require all employees to be vaccinated with a full 2-shot dose of one of the authorized COVID-19 vaccines. This is a very surprising development since under the Canadian Charter of Rights and Freedoms, an employer cannot force an employee to receive a vaccine unless it is a "bona fide occupational requirement". This may apply in a hospital or clinical setting but is difficult to justify amongst office workers.

I understand that xxxxx needs to meet our client's wishes and that employees sent to work at client sites have to adhere to our client's guidelines surrounding the COVID-19 response, including the need to be fully vaccinated. xxxxx employees who choose to not get vaccinated should be allowed to work in other positions which enables them to either work from home or at xxxxx offices.

As of today, 72.7 % of the Canadian population has received at least 1 dose of the COVID-19 vaccine (65.8% both doses). Of the 27% of the Canadian population who

have not yet stepped forward to “get the jab”, a number probably feel that they have a low chance of being impacted by COVID-19, so why bother. But for a great many of the unvaccinated, they feel they have a justified reason for refusing to take the shot.

We keep hearing from our leaders and media that there is scientific consensus regarding the efficacy and safety of the vaccines, as well as the need for masks mandates, social distancing and lockdowns. If you start digging a bit, you see that around the world there are a great number of very qualified doctors, health professional and scientists, including Nobel prize winners, that have serious concerns about how the whole COVID-19 pandemic is being handled.

All medical interventions have risks and side effects, whether it be medication, vaccines or medical procedures such as operations. A health professional should always balance the risk of an intervention vs. the risk of not intervening. When it comes to vaccines, this is always the challenge of public health, as they need to balance the benefits of the vaccine to the greater population versus the negative impacts to a much smaller group of individuals (ranging from short term impairment to long-term disabilities and even death).

The burden of proof for the safety and efficacy of any pharmaceutical product (including vaccines) has always been with the manufacturers who wish to sell their product. The bar is supposed to be set very high to ensure that any medication or vaccines that goes out to the general public are both safe and effective. Until this is proven to the regulators, use is generally limited to experimental settings or clinical trials.

With all COVID-19 vaccines, this high bar has NOT been met and were rolled out under emergency authorizations, with limited clinical trials and animal studies having been done resulting in what is essentially now a worldwide clinical trial with most of humanity as participants. It normally takes 5-10 years to get a vaccine candidate to be approved. Why? When a vaccine candidates are tested, although occasionally some of the time the negative impacts are so significant that they show up almost immediately, most of the time problems are cumulative and build up with time, with issues only show up in the medium (6-24 months) or longer term. This is why establishing the full safety profile of a vaccine takes a long time.

Doctors, health professionals and scientists have been voicing many concerns about these COVID-19 vaccines since the very beginning, especially since they are using a brand new approach: using what is essentially gene therapy to generate immunity. Unfortunately, the industry and governments, instead of addressing these concerns and taking actions when the points brought up are valid, have either ignored or suppressed any dissenting opinion.

Just so you can have an idea of what some of these concerns are, I have attached a document titled *COVID Vaccines: Necessity, Efficacy and Safety* prepared by the “Doctors for COVID Ethics” group. It is the first document that I have seen that presents and summarizes in a concise way the main concerns that many of the members of the

scientific and medical community have around the COVID-19 vaccines. The points they make are almost all backed up by links to scientific literature.

Even if you do not agree with some of the issues raised or conclusions presented in the documents, what I want you to get is a sense of the overall concerns that members of the medical and scientific community have identified. This in turn has led to many in the general public to come to a conclusion that there are definite short- and long-term risks around getting the COVID-19 vaccine which do not appear to have been addressed or taken in consideration.

Will all the concerns outlined in the document turn out to be actual problems or risks once proper due diligence is done? Certainly not, but from what I see, many of them are potentially serious enough to raise red flags and be considered sufficiently valid and serious risks to warrant definite consideration and investigation. Remember that the burden of proof is upon the vaccine manufacturers and the regulatory agencies, especially since COVID-19 vaccine manufacturers have been exempted from legal liability for any vaccine-induced harm. For the COVID-19 shots, the high bar of proving “safety and efficacy” that we have come to expect for our vaccines has NOT yet been met.

Even the FDA approval in the U.S. of the Pfizer vaccine a few days ago is unprecedented. The clinical trials to prove vaccine safety were designed to run into 2023 with final results of the Phase 3 clinical trials only available then. Numerous health professionals are very concerned that the FDA has given their full approval without any regards to medium to long-term safety data. Because of the potentially serious medium to longer term risks, many believe the vaccine should have been kept under the current Emergency Use Authorization until the full results of the clinical trials are in.

As leaders of xxxxx, I understand that you have a responsibility towards your employee’s health and safety during this pandemic and also need to adhere to government regulations and guidelines. I ask that you proceed with Respect, Objectivity and Integrity which are part of the xxxxx core values and our corporate DNA. Because of the potential risks and uncertainties, you have to allow all xxxxx members in Canada and around the world the freedom to choose whether or not they wish to be vaccinated.

ACIP vote yesterday after deceitful CDC briefings removes liability from Comirnaty, opening the door to mandates

In a nutshell: Yesterday CDC asked its advisory committee to "recommend" the Comirnaty vaccine for 16 and 17 year olds. And it agreed, unanimously. Or pusillanimously.

The vote may seem silly or superfluous, because it had already been recommended for this age group as an EUA.

But this vote was anything but superfluous. This seemingly minor recommendation, which did not get headlines, moves the licensed Comirnaty vaccine from a place where the manufacturer is legally liable for injuries, to a berth within the Childhood Vaccine Injury Compensation Program, for which there is no manufacturer liability. Instead a \$0.75 excise tax is charged per dose, which goes into a fund administered by DHHS to pay for injuries, if one is lucky enough to convince the special masters (judges) in the program that a vaccine caused your injury. Once a vaccine is recommended for children, its liability is waived no matter who receives it.

But the important part is that once this process is complete (which I expect to be only a very few weeks), Pfizer can roll out stocks of the licensed vaccine while still having its liability waived. That means that the loophole I told you about last week is being backfilled by the USG, with the help of the supine and spineless ACIP committee members, and will soon disappear. I say spineless with true conviction, because the briefings they received yesterday were a load of fraud and hogwash. Yet no

one challenged the data nor the conclusions. It is hard to believe that the lot of them are really that stupid that they believed what they heard. It is also hard to believe that none of them had a conflict of interest, which they all asserted along with their vote. Furthermore, no one ever actually said why the vote was held: which was for liability purposes, nor that the vote would lead to mandates, which could not be implemented under the EUA. So, it is disappointing.

Children's Health Defense went to court today in Tennessee to challenge the FDA on issuing both a license and EUA for the same product. AFLDS also went to court today in Colorado challenging the mandate. More on these cases later.

One such person is Stephanie Seneff, Senior Research Scientist, MIT Computer Science and Artificial Intelligence Laboratory

Here is her response to the information I shared with her:

“Your message is very timely – I have been spending every spare moment the last few days digging through the research literature to connect the dots on the links between the vaccines and cancer. I was tipped off by others who spoke of stories like yours. I am extremely worried about the likelihood that we are going to see a tremendous rise in multiple cancers, and perhaps the most worrisome one is glioblastoma – the most aggressive form of brain cancer.

I am actually trying to piece together an article on this very topic to put on my web site or in some online magazine, at the moment just gathering articles and notes. The story is looking pretty compelling, and Greg and I got part way there with our hypothesis that the

dendritic cells in the spleen would release exosomes containing spike protein that would distribute throughout the body. I have since learned that those exosomes are indeed produced by exposed cells, and, furthermore, that they can be taken up by microglial cells in the brain and cause an inflammatory response. See the attached remarkable paper.

However, worse than that, the exosomes also contain certain miRNAs that have the powerful ability to suppress certain proteins. One protein that I think is severely impacted is PTEN, which is one of the most powerful tumor suppressor proteins. So, when PTEN gets suppressed, the tumor grows.

The attached article specifically mentions miR-148a and miR-590. Both of these are associated with glioblastoma. miR-590 is well known for its ability to promote all sorts of cancers. miR-148a is well known for its ability to promote all sorts of autoimmune diseases.”

I have a few other correspondence with she and Dr. Petr McCullough where they share additional papers relative to the EI's and cancer but they went above my comprehension.

Sharing in hopes that if there are any dots to be connected that others will come forth with similar stories and additional truths will be revealed about the adverse impact of the EI's.

My husband and I are subscribers to Solari. Thank you for your content and hard work. I am writing to you today in order to provide you with some low-level intelligence and to ask for your assistance and/or opinions.

My husband, James, is theXXXXX. . For 20 years, we have lived in Virginia. We've gone as local as we could. We paid off our house in 2014. We belong to a local farm co-op. We frequent the local farmer's market. We got out of the big banks a long time ago. We LOVE cash Fridays. But we are alone out here. Most of our family is back in XXXXX.

For the past 8 months, MY HUSBAND has been exercising his right to not take a the "voluntary vaccine." His unit, XXXXX has had a voluntary uptake of 92%, and for the most part, has left him alone. So far in his unit, they had one death, (not attributed to the injection, but rather a pre-existing heart condition. This is Arizona specific, but I am sharing to inform other people, so you can look into your state specific programs and hopefully find something similar. If you do, please post it!! Besides pulling your kids out of school, this is another good option for people that do not have kids in school.

This info is from my friend:

Stop sending your state income tax money to the public schools. You can help kids get a better education through the Scholarship Tuition tax credit program.

In the state of Arizona, you can direct your state income tax liability to the private school, or private school student, of your choice. This is done by making donations to specific Scholarship Tuition Organizations (STO) (https://azdor.gov/sites/default/files/REPORTS_sto-i-list.pdf) and then claiming the credit when you file your state income taxes. The total amount deductible is \$611 for single, and \$1221 for married, joint filing, for the Original Tax Credit, and then an additional \$608 (single) and \$1214 (married, filing joint) for the Overflow Tax Credit. This year, a single payer can claim \$1219 and married, filing jointly, can claim a tax credit of \$2435.

The beauty of the law is that if you don't know what you owe in state income taxes, you can wait until you receive your W-2 in January and then make your donation to the STO

of your choice. You will be credited that amount in your tax filing. You have until April 14 to make your donation.

I am new to this state and my tax liability for 2020 was pretty limited. If I had known about this program, or more to the point, understood it, I would have directed even that small amount to Arizona Christian Scholarship Tuition Organization (acsto.org) This is the STO that I have the most connection with because of my church and now because Good News Christian Academy (goodnewschristianacademy.com) has partnered with ACSTO to provide scholarships for our students.

You can look at the list provided by Arizona Department of Revenue to choose a different organization, if you would like. I will say, donating to ACSTO will help support our new venture.

I believe no Arizona tax payer should not be participating in this program. This is the simplest way to affect public education. When you designate your state income tax dollars to the school/student of your choice, you are helping kids get a better education. If you simply leave your state income tax (this does not apply to federal income tax) to the department of revenue, they will be sending the money to the public school general fund. How is your local public school performing? Do you really want to support that school?

What can you do? First, figure out your tax liability. Look at last year's tax filing. How much did you pay in state income tax? Next, pick an STO from the list and go to their website to find out their process. If you already know a private school you would like to support, go to their website and check to see if they are already connected to an STO. If you cannot make a donation now, plan to make a donation in January (or whenever you file your taxes). In many cases, you can make your donation on a credit card, file your taxes, and get the credit before you get your credit card statement. Well, that is what I have been told by STO participants.


